* Members' Rates in this connection, means practice balls for range are available at the discounted rate for members (currently £1 for a basket of balls), free trolleys, if required, and the ability to take guests on to the South Links Course at the Members Guest rate of £3 For all Memberships that allow play on the main Craigielaw Course, the Member can take introduce guests to the Course. The guest rate for the 2011/12 Season is £19.50 for weekdays and weekends. A reduced Members guest rate of £15.00 is applicable in the months of November to February. Members can purchase a book of 12 pre-paid guest tickets at a cost of £180 (£15.00 per ticket). These can only be purchased at subscription renewal or at the time of joining. Members must play with their guests and can take on no more than 3 guests at one time, at the guest rate.

BENEFITS OF MEMBERSHIP

- Membership of Craigielaw Golf Club
- Members can obtain and maintain a handicap. Members with an official handicap may play in Club Competitions.
- The Company reserve the right to all tee times, however members will be able to reserve tee off times up to one week in advance. Members' priority tee times will be between 7.30am-9.00am and 11.30-1.30pm (7 days).
- The number of Members, in each category, is strictly limited by the Company.
- Members may introduce guests.
- Members will have full use of all the golf facilities in the Clubhouse, as determined by the Company and by their Membership category.
- Members have use of the Foreshot Golf Academy. Members receive practice balls at a discounted rate.
- Members may be able to move between membership categories following a change in personal circumstances, at the discretion of the Company.
- For the 2011/12 Season, Members will receive a discount in the Bar/Restaurant of 10%, on production of their membership card. The discount also applies to goods in the Pro Shop that carry the Craigielaw logo.

- For the 2011/12 Season, Members and their playing guests (up to maximum of 3) can use the golf trolleys free of charge. Members also received discounted rates on electric buggies (£30 per round). The members guest rate for the South Links Course is £3.
- The foregoing benefits will be subject to modification from time to time but not so as to result in a material reduction in the benefits.

NOTES:

- Members will have the option to spread payment of Entrance Fees and Subscriptions through an agreement with Fairway Credit (currently 10 monthly payments by direct debit, collected by Fairway Credit. Full details are available on request).
- Unless stated otherwise, all entrance fees, subscriptions and green fees are inclusive of VAT (at the going rate), where applicable.

CONDITIONS:

- The annual Membership runs 1 April - 31 March. Those failing to renew their subscription by 7th April shall be deemed to have resigned.
- The Company reserves the right to refuse any application for membership without reason and may require prospective Members to attend an interview.
- Memberships are strictly non-transferable.
- Members are requested to book their tee times in advance.
- The Company will be responsible for administering handicaps and competitions under the C.O.N.G.U. Rules. The Company will provide all necessary administrative materials.
- There will be Society and Corporate bookings during the week and exceptionally at weekends, although not on Club Competition days. The Company retains the right to book tee times for Society and Corporate days in advance.
- Visiting parties must book in advance. Members will be notified in advance on the noticeboard of society and corporate bookings and other advance visitor bookings.
- The Company reserve the right to close the course on a maximum of 10 days per year only for special events and purposes e.g. PGA/SGU/R&A competitions and other golfing events. The Company will on each occasion liaise with the Members' Liaison Committee
- A handicap is not a pre-requisite for membership. Where a prospective Member does not have a registered handicap, they would require to satisfy the Company of their ability.

RULES AND BYE-LAWS – SUMMARY

Ownership

- The Club is a proprietary Company, to be known as Craigiellaw Golf Club. The proprietor is Wemyss and March Estates Gosford Limited ('The Company').

Management

- The Management of the Club will be undertaken by the Company, who will employ such persons as are necessary for the management of the Golf Club.
- The Company may add to, repeal and amend the Rules and Bye-Laws, as may be necessary for the efficient and harmonious running of the Company.
- The Course and Clubhouse shall open at such hours as the Company may, from time to time, determine. The Course will not open before 7.30 a.m., unless otherwise stated by the Company. The Company may close the Course or Clubhouse to meet the prevailing circumstances, but will always try to give sufficient notice of its intentions. In the case of bad weather conditions, a last minute decision may be unavoidable.
- The Company shall have the sole authority for the interpretation of all Club Rules and Bye-Laws.

Bookings

- All those booked to play must sign in and pay the appropriate green fees, prior to playing.

Discipline

- The company reserve the right to expel any person if they abuse the Rules and Bye=Laws, or any person deemed to bring the Club into disrepute.
- If the conduct of any Member is such as it appears to the Company to endanger the character, interests, or good name of the Club, it shall be in the power of the Company, after calling upon the Member for an explanation, to suspend, or expel such Member, for such period as the Company may determine.
- Anyone wishing to file a complaint about any aspect of the running of the Company may do so in writing to the Golf Club Manager.
- Golfers are requested to remain within the boundaries of the Course.
- Dogs are allowed on the Course but must be kept on a lead.

Liability

- The Company is not responsible for any loss or theft of Members' property incurred whilst on the premises, with the exception of the Professional's equipment store.
- Members and their guests are required that they have suitable insurance cover, to include Public Liability.
- Membership of Craigelaw Golf Club confers no financial liability or responsibility upon the Member for any of the liabilities of the Company, save for the payment of a Joining Fee and/or an annual Subscription.
